***REMINDER: Temporary licenses will only be issued in conjunction with organized charitable, civic or community sponsored events, i.e. fairs and festivals. Holidays such as Christmas, Easter and Lent are not considered events. Therefore, temporary licenses will not be issued for holiday seasons. Applicants must obtain temporary licenses for each qualifying event being conducted during a holiday season.***

Attach a copy of the State’s “Basic Application for Alcoholic Beverage License” with attachments, Advertisement of Intent, Schedule for type license applying for, Fire Marshall verification of seating for a restaurant and appropriate license fee. Make checks payable to the City of Elizabethtown.

**I understand that a Regulatory Fee of 4% on all gross sales of alcohol is imposed and that I will receive a credit for the base fee of my City license cost. This regulatory fee shall be the larger of the base fee or 4% of all alcohol sales.**

**I further acknowledge and understand that Elizabethtown has a mandatory training provision in its ordinance that requires all persons involved in the serving of alcoholic beverages by the drink shall participate in and complete a responsible beverage service training program within thirty (30) days in which the person first becomes subject to training. I certify that this requirement is being or will be met.**

*I do hereby solemnly swear or affirm that all statements contained in this application and all attachments are true and correct to the best of my knowledge, information and belief. I understand I may not begin to operate with alcohol activity until a license(s) has been issued. I further swear or affirm I shall abide by all state and local statues, regulations and ordinances relating to the sale, use or trafficking in alcoholic beverages. I hereby authorize the release of Police and/or Criminal records to the City of Elizabethtown ABC Administrator.*
