ORDINANCE NO. 22-2016

AN ORDINANCE FOR THE CITY OF ELIZABETHTOWN, KENTUCKY CLOSING A PORTION OF RIGHT-OF-WAY KNOWN AS STRAWBERRY ALLEY (LANE) AND THE ENTIRE LENGTH OF AN UN-NAMED ALLEY OFF THOMAS STREET, MAKING APPROPRIATE FINDINGS OF FACT AND AUTHORIZING TRANSFER OF SAID PROPERTY

BE IT ORDAINED by the City of Elizabethtown, Kentucky, that from and after the passage, approval and publication of this ordinance that a portion of Strawberry Alley (Lane) and the entire length of an un-named alley off Thomas Street, as more particularly described in Exhibits "A" and "B" (Strawberry Alley) and Exhibits "C" and "D" (Un-named Alley) is hereby closed to any and all vehicular traffic pursuant to KRS 82.405, Sections (1) and (2).

The Elizabethtown City Council hereby makes the following findings of fact:

A. The following property owner is the only property owner on and abutting said portion of right-of-way known as portion of Strawberry Alley (Lane) and the entire length of an un-named alley off Thomas Street to be closed:

- B. Written notice of the proposed closing was given to the property owner on and abutting said portion of right-of-way known as portion of Strawberry Alley (Lane) and the entire length of an un-named alley off Thomas Street to be closed.
- C. The property owner on and abutting said portion of right-of-way known as a portion of Strawberry Alley (Lane) and the entire length of an un-named alley off Thomas Street to be closed has given their written, notarized consent to the closing, (copy of same is attached hereto as Exhibit "E").

Pursuant to the above findings of fact and to KRS 82.405, the Elizabethtown City Council hereby determines that the portion of right-of-way known as a portion of Strawberry Alley (Lane) and the entire length of an un-named alley off Thomas Street should be closed and that the owner on and abutting said portion of right-of-way known as a portion of Strawberry Alley (Lane) and the entire length of an un-named alley off Thomas Street, City of Elizabethtown, agrees to said closing.



Ordinance, including but not limited to execution and delivery of a Quit Claim Deed to City of Elizabethtown, the appropriate adjoining property owner.


